

## **Competition, Prize Draw or Giveaway Terms and Conditions**

### **Care Professional Academy**

#### **1. Introduction**

- 1.1.** These Terms & Conditions apply to all competitions, prize draws, giveaways and suchlike that are promoted on and run by the Care Professional Academy (CPA).
  
- 1.2.** Promotions on social media or through the Care Professional Academy communications are in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram, LinkedIn or any other social network. You are providing your information solely to the Care Professional Academy (CPA) and not to any other party. The information provided by you will be used in conjunction with our [Privacy Policy](#).

#### **2. Eligibility and entry restrictions**

- 2.1.** To be eligible to enter a competition:
  - 2.1.1.** You must be a real person, at least 18 years old, and permanently reside or be physically located in the United Kingdom or the Isle of Man (proof of address or age may be required)
  
  - 2.1.2.** You must work in Adult Social Care

- 2.2.** The maximum number of entries to a competition per person is 1.

### **3. Start and closing dates**

- 3.1.** A Prize Draw and/or Giveaway shall open for entries at the time and on the date specified on our website, portal, social media channels, and/or email communications. Similarly, we shall close entries at the time and on the date specified on our website, portal, social media channels and/or via email communications. Unless otherwise stated, these times and dates are set to Greenwich Mean Time (GMT).
- 3.2.** Any members who join after the closing of a Prize Draw and/or Giveaway will be invalid and will not be entered into the Prize Draw and/or Giveaway.
- 3.3.** No responsibility can be accepted for applications not received for whatever reason.

### **4. Winner Selection**

- 4.1.** Prize Draw and/or Giveaway entries shall be randomly selected on the basis of those criteria specified on our website, portal, marketing channels and/or social media platforms.
- 4.2.** The Care Professional Academy will decide the time, frequency, date and method of selection of a winner for each Prize Draw and/or Giveaway.

Reasonable efforts will be made to contact the prize winner for 14 days by the Care Professional Academy but if the winner fails to respond to our notification attempts within this time or provides an address for delivery of the prize or fails to meet any of the eligibility requirements or is otherwise unable to comply with these Prize Draw and/or Giveaway terms and conditions, we reserve the right to offer the prize to the next eligible entrant, and thereafter, until a winner is found.
